

LANDSHARK® SHARK DIVE GIVEAWAY - OFFICIAL RULES

2. The “Landshark Shark Dive Getaway” (“Sweepstakes”) is open to legal residents of the (50) United States and District of Columbia who are 21 years of age or older. Void where prohibited.
